

## Item 1 – Introduction

Lindbrook Capital, LLC (“we”, “us” or “our”) is registered with the U.S. Securities Exchange Commission (“SEC”) as an investment adviser. Investment advisory services and compensation structures differ from that of a registered broker-dealer, and it is important that you understand the differences.

## Item 2 – Relationships and Services

### What investment services and advice can you provide me?

We provide comprehensive portfolio management services, which include investment management and financial planning services, on a discretionary and non-discretionary, wrap or non-wrap basis. We also offer portfolio monitoring services for clients with non-managed accounts. Our services are available to individuals, trusts and estates (our “retail investors”).

When a retail investor engages us to provide comprehensive portfolio management services we shall monitor, on a continuous basis, the investments in the accounts over which we have authority as part of our investment management service. Furthermore, when engaged on a discretionary basis, we shall have the authority, without prior consultation with you (unless you impose restrictions on our discretionary authority), to buy, sell, trade and allocate the investments within your account(s) consistent with your investment objectives. Our authority over your account(s) shall continue until our engagement is terminated.

We may also be engaged, for a separate fee, to provide portfolio monitoring services. We provide these services with no on-going supervision, trading, nor discretion with respect to securities transactions. Clients are responsible for placing and executing their own trades, either on their own or with another investment adviser.

We do not limit the scope of our investment advisor services to proprietary products or a limited group or type of investment.

## Item 3 – Fees, Costs, Conflicts, and Standard of Conduct

### What Fees will I pay?

We provide our comprehensive portfolio management services on a wrap and non-wrap basis. When engaged to provide these services, we shall charge a fee calculated as a percentage of your assets under our management (our “AUM Fee”). Our annual AUM Fee is negotiable but does not exceed 1.00%. We do not generally require a minimum account balance or impose a minimum annual fee on these services.

We typically deduct our AUM Fee from one or more of your accounts, in advance, on a quarterly basis. Because our AUM Fee is calculated as a percentage of your assets under management, the more assets you have in your advisory account, the more you will pay us for our investment management services. Therefore, we have an incentive to encourage you to increase the assets maintained in accounts we manage.

We also offer our portfolio monitoring services on a separate fee basis. The fee for this service is generally calculated as a percentage of the value of the assets subject to our monitoring services and does not exceed 1.00%

**Other Fees and Costs:** Your investment assets will be held with a qualified custodian. Custodians generally charge brokerage commissions and/or transaction fees for effecting certain securities transactions or maintaining

certain types of accounts. Clients who engage us on a wrap fee basis shall not incur brokerage commissions and/or transaction fees in addition to our AUM Fee.

In addition, relative to all mutual fund and exchange traded fund purchases, certain charges will be imposed at the fund level (e.g. management fees and other fund expenses).

You will pay certain fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

**What are your legal obligations to me when acting as my investment adviser?**

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. As an example, we may recommend a particular custodian to custody your assets, and we may receive support services and/or products from that same custodian, certain of which assist us to better monitor and service your account while a portion may be for the benefit of our firm.

**How do your financial professionals make money?**

Our financial professionals are compensated on a salary basis. However, certain of our financial professionals, based upon their individual professional ability, may receive a performance bonus from time-to-time. You should discuss your financial professional's compensation directly with your financial professional.

**Do you or your financial professionals have legal or disciplinary history?**
